ITEM 3 Site Allocations

A site to the right of Bramham Road had been assessed for potential development by the Development Group using the LCC Development Plan Document as a template. A long discussion took place on the merits of taking this forward and speaking to the land owner. It was agreed that the thoughts of the PC should be sought before any further action.

A response to a planning application for SHLAA site 1008 on Grove Road has been drafted, Boston Spa PC and NP Group had been consulted so that a coherent responses would result. The response was now with the relevant groups for comment prior to submission. Details be entered onto the Web site.
